Privacy Notice

The Young Critics Programme 2021 is part of the Edinburgh International Film Festival, which is part of the Centre for the Moving Image. As part of this application, we will collect and process personal data relating to our recruitment process. We are committed to being transparent about how we collect and use that data and to meeting our data protection obligations.

This notice sets out the basis on which we collect, use and disclose the personal data of our applicants, as well as your rights in respect of such personal data.

What information do we collect and how?

This application will collect a range of information about you. This includes:

- your name, address, and contact details, including email address and telephone number;
- details of your qualifications, skills, experience, and employment history;
- equal opportunities monitoring information, including information about your age, ethnic origin, sexual orientation, health, and religion or belief.

This data will be collected through our Application form.

Once received your data will be stored on a private, secure channel.

Why is the Young Critics Programme processing personal data?

The Young Critics Programme, as part of the Edinburgh International Film Festival, will collect and process your data for a number of purposes and where we have a legal basis to do so, as follows.

Edinburgh International Film Festival has a legitimate interest in processing personal data during the recruitment process and for keeping records of the process. Processing data from applicants allows us to manage the recruitment process, assess and confirm a candidate's suitability.

We may process information about whether or not applicants are disabled so we can make reasonable adjustments for candidates who have a disability. Where we process other special categories of data, such as information about ethnic origin, sexual orientation, health or religion, or belief, this is for equal opportunities monitoring purposes. Our processing of these types of data will be carried out to make sure that the project is meeting its intended goal of reaching groups that are underrepresented within

film criticism. This personal data will not be used in the initial shortlisting process but will be used in the final selection process to make sure the project is fulfilling its intended aim of expanding diversity.

Data relating to the Equality and Diversity Form will be anonymised and aggregated for use in our funder's report. This will be done to provide our funders with evidence that we have reached our intended goal of reaching marginalised and disadvantaged communities.

Who has access to data?

Your general application form will be separated from your Equalities and Diversity Monitoring Form.

Your application form may be read by any member of the Edinburgh International Film Festival's Learning Team. Your Equalities and Diversity Monitoring form will only be available to our Young Critics Programme Senior Coordinator and our Young Critics Programme Assistant from the date you submit it to the 5th of September 2021.

On the 5th of September Yvonne Gordon, Head of Community Engagement and Learning will become the Data Controller for this project's data.

How do we protect data?

All of your data will be stored in a private, secure channel. From the date of your submission to the 5th September your Equalities and Diversity data will be available to our Young Critics Programme Senior Coordinator and the Young Critics Programme Assistant only. While other members of the Learning Team may be asked to read your application form, all personal data will be removed.

From the 5th September 2021 to 26th January 2022 Yvonne Gordon, Head of Community Engagement and Learning will be given access to the folder and will delete all data on the 26th January 2022.

For how long do we keep data?

All data will be deleted no more than six months after the application deadline.

Your rights

As a data subject, you have a number of rights under data protection law. You can:

- access and obtain a copy of your data on request;
- require Edinburgh International Film Festival to change incorrect or incomplete data;
- require Edinburgh International Film Festival to delete or stop processing your data, for example where the data is no longer necessary for the purposes of processing;
- object to the processing of your data.
